# Eligibility 申请资格

- **Geographic scope:** China and UK. Relevant third countries (e.g. links to Belt and Road Initiative) considered on a case by case basis.  
地理范围：中国和英国。相关第三国（如：一带一路相关的国家）则以个案评估。
- **Type of support funded:** Policy making and implementation; Research development; Capacity building and technical exchange, Industrial strategy; Commercial partnerships.  
资助的类型：政策制定和执行；研究发展；能力建设和技术交换；行业战略；商务合作。
- **Grant size and duration:** £50,000 to £250,000 for a project of 6-12 month; £150,000 to £2,000,000 for a multi-year (+12 months) project.  
款项规模和时长：针对周期为6到12个月的项目，赠款建议金额将在5万英镑至25万英镑的范围内；针对周期为一年以上的项目，赠款建议金额将在150万英镑至200万英镑的范围内。
- **Joint concept notes:** Joint / Collaborative Concept notes are permitted.

- **Number of concept notes:** multiple Concept Notes from a single entity are permitted.

- **Legal status:** Lead entity must be registered in the UK or China : Private sector companies; Civil society organisations/NGOs, International nongovernmental organisations; Research organisations and policy institutes/ think tanks; Trade or industry associations; Non-membership associations, professional associations and foundations; Individuals.

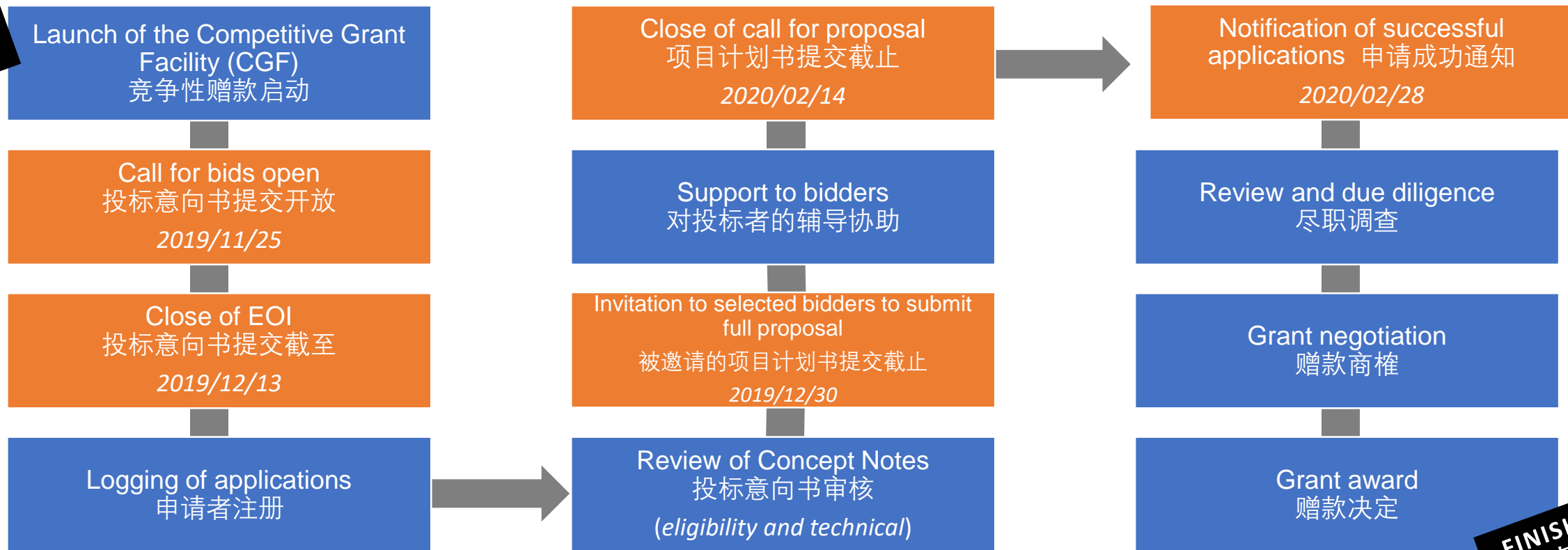
- **Where applicants will not be funded:**
  - Investment in fixed assets
  - Concept notes that are better suited for funding from other programmes or sources
  - Concept notes that do not demonstrate sufficient additionality
  - Concept notes that represent unacceptably high levels of risks
  - Concept notes that do not significantly advance the strategic outcomes of the programme
  - Concept notes that do not show good value for money
